## Benefit Spotlight: Over-the-Counter (OTC) Benefit Allowance

For each calendar quarter (Jan – Mar, Apr – Jun, Jul – Sep, Oct – Dec), you will be provided a \$25.00 allowance to purchase select OTC products featured in the OTC Product Catalog that Highmark Blue Shield will mail to members. The allowance may be used on over 400 different products, including cold and cough medicines, pain relievers, vitamins, dental care, first aid, and many more categories to choose from. Members order their OTC products via a specific website or by telephone. Free shipping and handling is provided for one OTC order per quarter. Since you receive \$25.00 per calendar quarter, this is an annual benefit worth \$100.00 to obtain OTC products that you likely are already purchasing.
