Critiques of the social work licensure process have received an increase in nationwide attention since ASWB released data in 2022 revealing a significant racial bias that unfairly disadvantages some groups (social workers of color in particular) in exam pass rates. This elective course was developed in response to these concerns with a particular focus on test-taking strategies for students who have historically struggled with standardized testing and/or feel impacted by the structural bias of the current exam process.

Students will engage in a critical examination of the intricate interconnections within these systems and their implications for our work with marginalized clients and societal structures. Operating within an anti-capitalist framework, this course delves into multiple critical theories: critical race theory, gender/feminist theory, queer theory, and social movement theory, as wellsprings of resistance against the dominance of capitalism and market-oriented ideologies.
